<p></p><p>A tweet from Phil Spencer, Microsoft Gaming's CEO, read: We are pleased to announce that Microsoft and @PlayStation have signed #127771; a binding agreement to keep Call of Duty on PlayStation following the acquisition of Activision Blizzard. We look forward to #127771; a future where players globally have more choice to play their favorite games. </p>
<p>In the United States, the FTC had argued #127771; the acquisition deal would hurt consumers whether they played video games on consoles or had subscriptions because Microsoft would have #127771; an incentive to shut out rivals like Sony Group.</p>
<p>However, Judge Jacqueline Scott Corley ruled on 11 June: The FTC has #127771; not shown it is likely to succeed on its assertion the combined firm will probably pull Call of Duty from #127771; Sony PlayStation, or that its ownership of Activision content will substantially lessen competition in the video game library subscription and #127771; cloud gaming markets. </p>
