A tweet from Phil Spencer, Microsoft Gaming's CEO, read: We are pleased to announce that Microsoft and @PlayStation have signed &#128184; a binding agreement to keep Call of Duty on PlayStation following the acquisition of Activision Blizzard. We look forward to &#128184; a future where players globally have more choice to play their favorite games. &#233;

In the United States, the FTC had argued &#128184; the acquisition deal would hurt consumers whether they played video games on consoles or had subscriptions because Microsoft would have &#128184; an incentive to shut out rivals like Sony Group.&#233;

However, Judge Jacqueline Scott Corley ruled on 11 June: The FTC has &#128184; not shown it is likely to succeed on its assertion the combined firm will probably pull Call of Duty from &#128184; Sony PlayStation, or that its ownership of Activision content will substantially lessen competition in the video game library subscription and &#128184; cloud gaming markets. &#233;

To address the FTC's concerns, Microsoft had agreed to license Call of Duty to rivals, including a 10-year &#128184; contract with Nintendo, contingent on the merger closing.&#233;
